

**GOFFSTOWN BUILDING DEPARTMENT FEE SCHEDULE**

**NEW CONSTRUCTION:**

Fees are based on square footage, total of all floors.

Fees are additive; basic construction fee plus Electrical, Plumbing, Mechanical, etc.

**ADDITIONS AND REMODELING:**

Fees are based on square footage, there is a minimum fee.

**CALCULATING:** Square area upon which fees are based, shall be the sum of all the gross horizontal areas of all the floors of the building and including cellars, basements and usable parts of attics; except that in dwelling houses, attic floors shall not be include in the calculation unless they are used for habitable rooms.

**ALL HORIZONTAL DIMENSIONS:** shall be taken from the exterior face of the walls.

**REINSPECTION**

Failure of an initial inspection will result in a <u>re-inspection</u> fee for each inspection required to insure compliance if the inspection cannot be performed at the next required inspection.	\$30.

Sign Permit - Commercial (1 only, all types)	\$50.
For each add'l sign (at time of application) OR face change only	\$25.
Sign Permit - Industrial (1 - detached)	\$50.
For each add'l sign (at time of application) OR face change only	\$25.
Temporary (All) Issued for 30 days	\$10.
